ReBulet to Dallas dated 5/14/65, setting forth results of FBI Laboratory examination.

Enclosed herewith for the FBI Laboratory are the following items:

1. Originals of Qc3, Qc6, Qc7, and Qc8; namely, four cashier's checks Nos. 21983 through 21986, each dated 10/22/62, each purchased by "AL MEADOWS", and each purchased at East Dallas Bank and Trust Company, Dallas, Texas.

2. Copy of a registration card from the Marriott Motor Hotel, Dallas, Texas, showing the guest signature as FRANK WARD, and bearing handwriting in addition to the signature and prepared by "WARD". This handwriting is, namely, "1229 Ayers", "Corpus Christi, Tex.", and "Bedford Oil Co".

On 5/19/65, information was received from Dallas PCI JACQUELYN CHEWNING to the effect that subjects of this case, DRISCOLL and GRIMES, (who are also subjects of Dallas files 162-49 and 162-329, respectively), along with known Dallas area gamblers JERE BEDFORD JORDAN (DL 162-327) and EDDY TOM GREEN (DL 162-330), enticed Tulsa, Oklahoma, banker LYNN HELM to Dallas to participate in a crap game at the Marriott Motor Hotel on 4/26/65. Further details concerning this matter will be furnished the Bureau by separate communications.

During the investigation of this matter, it was ascertained that JERE BEDFORD JORDAN, FBI No. 14125B, has been tentatively identified as the person who prepared the enclosed registration card. It should be noted that JORDAN claimed as his firm the "Bedford Oil Co".
