## ADMINISTRATIVE

On December 11, 1962, JAMES MILES JACKSON. Owner. MILES JACKSON DRILLING COMPANY, Midland National Bank Building, Billings, Montana, who requested that his identity be protected with regard to this information, advised SA LAWRENCE D. TALBOT that he has received the impression that an officer in the GREENVILLE AVENUE STATE BANK, Dallas, Texas, possibly a Vice-President, was handling the account for MEADOWS on a personal basis and might possibly be involved in the operations of MEADOWS. JACKSON said this was just an assumption on his part. but it was odd that he was told to make out the \$5,000.00 bank draft to the above Bank. As he recalled, this Bank official was the person who told him how to make out the draft. He said this draft was delivered to this Bank by J. B. DRISCOLL, Arlington, Texas. JACKSON is of the opinion that DRISCOLL is a legitimate businessman and has no connection with the gambling operations of MEADOWS. JACKSON does not know the name of the above Bank official but he said DRISCOLL might know this person. DRISCOLL did know this money was in payment of a gambling debt.

The information received from the records of the MIDLAND NATIONAL BANK, Billings, Montana, on December 11, 1962, was furnished by Mr. M. A. BARRY, Assistant Cashier, to SA LAWRENCE D. TALBOT.

It is to be noted that the MILES JACKSON DRILLING COMPANY also maintains an office at Duncan, Oklahoma.
