Re DL airtel 12/17/62 entitled, "CRIMINAL INTELLIGENCE PROGRAM, WEEKLY SUMMARY, DALLAS DIVISION."

The Criminal Intelligence Program, Weekly Summary, Dallas Division, dated 12/17/62, reflected information received from DL informant 141-C that DL gambler WILLIAM RAY DAVIS owed \$18,000 to a Baton Rouge, La., bookie named FRANK BUSH (PH). The informant alleged that DAVIS contacted GILBERT LEE BECKLEY to relieve pressure on DAVIS and the informant was of the opinion that BECKLEY had actually paid DAVIS' debt.

Informant also alleged that BECKLEY had contacted SANTO TRAFFICANTE, Tampa top hoodlum, who in turn contacted CARLOS MARCELLO, New Orleans top hoodlum, to "call off the thugs."

FRANK BUSH (PH), Baton Rouge gambler, is possibly identical with FRANK LEO VUCI, prominent Baton Rouge gambling figure, who is subject of NO file 165-96 entitled, "FRANK LEO VUCI, ITWI, ITAR-GAMBLING," OO-NO.
