 HORSESHOE CLUB OSTENSIBLY TO EAT AT THE RESTAURANT. UPON  
 OBSERVING THESE INDIVIDUALS IN THE RESTAURANT BENNY BINION,  
 ACTING AS HOST, JOINED THEM AT THEIR TABLE. ROSELLI REQUESTED  
 BINION TO TELEPHONICALLY CONTACT LEVINSON TO JOIN THEM WHICH  
 LEVINSON IMMEDIATELY DID. GENERAL CONVERSATION ENSUED RELATIVE  
 TO THE CURRENT ~~FGO~~ <sup>Federal Grand Jury</sup> BEING CONDUCTED IN LAS VEGAS RELATIVE TO  
 SKIMMING.
