BINION stated during February he had been contacted by an Italian by the name of LOCATTO (phonetic) who stated he had some word from another Italian in Los Angeles who had served time with BINION in the U.S. Penitentiary at Leavenworth. BINION stated the information was of no value to anyone and he thought the main purpose of this contact was to try to get some money from him.

BINION was contacted during March 1959, concerning suspects in an Interstate Transportation of Stolen Motor Vehicle case entitled JOHN E. CHAMBERS; UNSUB, (2) Roy McGrath; Ron Chambers, SU 26-17802; who had contacted him while in Las Vegas. BINION furnished information concerning the automobile that JOHN CHAMBERS, et al, were driving which was of assistance to Bureau Agents in identifying UNSUBS. Prosecution in this case was subsequently declined.

4. Will maintain contact with CURTIS TRAHAN, former employee of the Horseshoe Club, now associated with the Mint Casino, for information he can furnish relative to the activities, associates and travel of BINION.
