supplied by SU 386-C who stated that he had learned that BINION would stay no longer than August 15, 1959, inasmuch as it would be necessary to take BRENDA BINION to Fort Worth, Texas, where she was to enter Texas Christian University for the fall term of school.

Mr. ROBERT CAUDILL advised he had been in conversation with BINION and that he had received no information as to when a hearing would be held by the Supreme Court or Court of Appeals on BINION's writ of Habeas Corpus which was decided in BINION's favor by Judge WELSH of Philadelphia and was appealed by the United States Government. CAUDILL stated BINION would certainly make no attempt to invest in a gambling casino in Las Vegas or obtain a license from the Gaming Commission until a decision had been reached by the Courts on this appeal.
