## ADMINISTRATIVE:

This matter is being placed in a closed status because of the inactivity of the subject at this time. This case will be reopened in six months, and the Bureau advised of the subject's status.

It is to be noted the subject's son, JACK BINION, is an owner of record at the Horseshoe Club Casino. This ownership is in all probability the ownership of the subject and is in the son's name.

The Las Vegas Office presently has the Fremont Hotel and Horseshoe Club, both downtown Las Vegas hotel casinos, under investigation, and if there is any activity on the part of the subject, this case will be reopened and a report submitted.

`LV 69-C\* advised on 1/5/63, that ALLARD ROEN, a hotel executive of the Desert Inn Hotel, Las Vegas, Nevada, mentioned that (SIDNEY) KORSHAK told him that subject BINION was interested in buying him out at the Riviera Hotel.

KORSHAK does not own any interest of record in the Riviera Hotel or any other gaming casino in the state of Nevada. No other definite information has been developed which indicates that KORSHAK may have a hidden interest.

LV 20-C advised on 1/29/63, that subject BINION was considering the construction of a \$3,000,000 dude ranch motel and casino in Nye or Mineral County, Nevada, and if this project is consummated, he will sell out his interest in the Horseshoe Club of Las Vegas, Nevada.

LV 16-C advised on 3/12/63, that the subject was negotiating with Holiday Hotels to build a hotel and lease a casino to the subject.

The above information concerning the dude ranch and lease of a casino by the subject has not been confirmed through any other sources, nor has any recent information been developed concerning the subject's interest in going into a motel and casino operation.
