The informant could furnish no information regarding those persons. The informant has been well acquainted with BENNY BINION for many years and knows most of BINION's contacts. LV 223-C-TE on 11/7/66 examined photographs of the above 12 persons. The informant is closely associated with BENNY BINION. According to the informant, BINION did not know TOM BONKO, although BONKO, a Crow Indian, has claimed to know BINION. Numerous Crow Indians reside in the vicinity of BINION's ranch in Montana and, therefore, might know BINION, while he would not know them. Over two years ago, shortly after the burglary of instant bank, BINION heard a rumor, source not now recalled, that JERRY JARREL was involved in the burglary, but had an "iron-clad" alibi. The informant said BINION would have no details regarding the burglary nor any additional information.

The Phoenix Office by letter dated 11/29/66 relates that SUSIE, who was reported on page 69 of referenced report to be a girl friend of KIPP, is, in fact, Mrs. SUSAN KUMP, who has been interviewed. SUSIE had, through error, been reported to be associated with KIPP. BILL and SUSAN KUMP have been interviewed on several occasions and the Phoenix Office relates that the KUMPs indicated that DELL ADAMS, TOM BONKO and BILL KIPP frequented numerous bars in Scottsdale, Arizona, and, therefore, the fact that "JEANIE." who appears to be probably identical to a Scottsdale barmaid named JEAN ENG, might have known KIPP and ADAMS, but it does not appear to be of significance so as to warrant further investigation to locate her. No information was developed at Scottsdale, Arizona, to indicate that "JEANIE" was ever known The Phoenix Office also advised that on June 8, 1966, as JANET. a copy of Arizona driver's license number I-39171 issued to DELL ROY ADAMS was obtained. The data on the license was handprinted, except for ADAMS' signature. This license was, therefore,
