FROM LIGHTHOUSE VICINITY TO CUBA. ABOUT FORTY MILES FROM LIGHTHOUSE FOUR U.S. NAVY SHIPS ON MANEUVER MET SUNSPORT AND ASKED IF NEEDED HELP AND SAW THE MEN ABOARD SUNSPORT DRESSED IN CAMOUFLAGED BATTLE FATIGUES BUT LEFT THEM WHEN HUGHES ON SUNSPORT STATED THEY WERE GOING FISHING AND WOULD BRING BACK A BIG ONE. AT NORTH COAST OF CUBA NEAR NEVAS, ORIENTE PROVINCE, SUNSPORT TOOK ABOARD A CUBAN FISHERMAN WHO GUIDED LANDING, FISHERMAN THEN RELEASED. TWENTY DASH SEVEN, NOT FIFTY DASH SEVEN MEN WENT ASHORE ABOUT FIVE THIRTY AM ON OCTOBER FOUR, LAST, LED BY ARMENTINO FERIA PEREZ AND ROBERT FULLER. CUBAN VILLAGERS WELCOMED INVASION FORCE AND ASSISTED IN CARRYING ARMS. EACH INVADER HAD ONE CARBINE AND AMMUNITION, ALSO A FEW SIDEARMS. THESE WERE OBTAINED IN MIAMI AREA, SOME FROM TAMIAMI GUN SHOP BY JULIO LNU WHO HAD ALSO BOUGHT THE TWENTY DRUMS OF GAS. HUGHES AND WILLIAMS IN SUNSPORT RETURNED TO CASTLE ISLAND LIGHTHOUSE WHERE PICKED UP THE TWO CUBANS WHO STAYED WITH ALADINO. LACK OF VISAS TO ENTER U.S. JULIO LNU ON OCTOBER EIGHT, SIXTY, PAID WILLIAMS ONE HUNDRED DOLLARS AT FULLER-S HOUSE. HE ALSO HAD PAID ABOUT TWO HUNDRED TO MAKE SUNSPORT READY FOR TRANSPORT OF GAS.

SUNSPORT OPERATES ON DIESEL FUEL ON OCTOBER EIGHT, SIXTY, U.S. BORDER PATROL INVESTIGATOR, AUBREY GROOM, MIAMI, STATED THAT BRITISH OFFICE AT NASSAU ADVISED TO EXPECT HUGHES AND WILLIAMS AT MIAMI ON PAN AMERICAN FLIGHT AT THREE FORTY FIVE ON OCTOBER EIGHT. HUGHES AND WILLIAMS MET BY USBP AND RELEASED. BRITISH ADVISED THAT THE TWO CUBANS HELD ARE HORACIO CARRIZALES OR CANIZALES, BORN JUNE TWENTY DASH SEVEN, ONE NINE ONE ZERO, AT HAVANA, AND ABELARDO MARRERO ORTEGA, BORN MAY SIX, TWENTY DASH EIGHT, AT HAVANA.
