Enclosed is a copy of a report classified "Secret" received from a confidential source abroad on August 25, 1959. The confidential source abroad advised that the report was received from its Jamaica Office and noted that the substance of the report has been made available to Customs in Miami. (S)

Miami will advise whether it has received any indication that the Directorio Revolucionario has revived its activities in Miami, and whether the Masferrer's have any connection with the organization as indicated in the enclosed report. Miami will also advise whether Merola, who has been furnishing information to your office, has furnished any information concerning the meeting held on July 18, 1959, mentioned in paragraph six of the enclosure. Miami will identify Senor Duena, who is mentioned in this paragraph. (S)

Miami will also identify the two individuals mentioned in paragraph eight. In the event any of the information in the enclosed report is disseminated outside the Bureau, it should be appropriately paraphrased to protect the source. (AA)

Miami is also requested to submit its comments and observations concerning the information contained in the enclosed report.
