CARBONELL resides at 3614 N. W. 12th Ferrace, Miami, Florida, with his wife, MARIA DE LOS DOLORES ALFONSO CARBONELLS age 19.

On May 13, 1964, CARBONELL traveled to New York, New York, and established temporary residence at 46 Fort. Washington Avenue, where he shared Apartment 52 with OLGA MARIA FIGUEROA ANGEL, PRUDENCIO DUENAS, and HILDA MADAN, common-law wife of DUENAS, Shis mailing address, however, in New York City, is 581 West 161st Street, Apartment 53(5)

On August 15, 1964, CARBONELL's wife departed Miami via Greyhound bussen route to New York City. Upon arriving, she and CARBONELL moved into 617 West 141st Street, Apartment 52, New York City.

B. Employment

CARBONELL is a carpenter and cabinetmaker by trade. He has been employed by a number of carpentry contractors and cabinet shops, and has worked as a free-lance carpenter and cabinetmakers accepting jobs on a commission basis, as well as regular wages.

In the New York City area, CARBONELL and PRUDENCIO DUENAS are working together as "Prudy and Carl, Carpenters and Cabinetmakers, 581 West 161st Street, Apartment 53, SA 2-6463."

II. ACTIVITIES OF JOSE CARBONELL MARRERO (5)

CARBONELL presumably sent the following letter to CHAFIR HOMERO SAKER ZENNI at an unknown address:

May 19, 1964

"Dear (ROLO: (5)

"In accordance with the conversation held with you in the City of Toronto and because I am somewhat concerned over the lack of contact." I am writing to you to find out whether we are going to undertake the work of reporting on the counterrevolutionaries of Miami.

"As you know, PACO was suppose to meet me in So New York on Tuesday two days after my interview with you on the corner of Radio City from 9:00 to 9:05 p.m. I waited for him until 9:30 and he never showed up IS

"It is true that he told me that on account of Certain very important tasks," it could be possible that he would not see me for a little while and in case of too much delay, he would send another contact (5)

"It is well to note that since that time, no one has come to see me. (5)

"I have sent two letters to Cuba to the address that PACO fold me I could write, on the carbon paper which he left me, but I think we shouldn't continue writing without code (5)

"Concerning my trip to Cuba in a ship of 'worms it is not easy to obtain this but I am trying and I don't think I should delay too much so I don't create suspicion."

"I think that if you could send someone you know and could help me we could also do it here (5)

"I have spoken with several persons concerning the possibility of having an American citizen for the plant of the amateur radio and they have told me yes Naturally, I have done this very slyly so as not to create suspicion.

"What I don't know is the cost." I have been able to face the small costs up until now, and on these two trips, I have spent a lot.

("PACO told me that in Radio City and on the evening that he was suppose to meet with me, he was going to give me for the cost of the trip, and in spite of my refusing, he insisted. He told me that he was going to receive some money and that he was going to give it to me. As you know, PACO did not keep the date. (S)

"On many occasions, I asked PACO to permit IRMA to leave Cuba and to let ENA, CARMITA, JUAN SANCHEZ, ALBERTO MORALEZ, and ANTONIO GONZALEZ come out also. You know what the arrival of IRMA in Miami would mean to me, after sending her the letter written in lemon juice by mel and worded very skillfully by PACO 5

"You must know how important my friendship with IRMA and how far it has gone, for according to PACO, those letters were intercepted by you.

"I beg you to set IRMA free, and if possible, the rest of the fellows (S)

"PACO told me that in case of delay and if there was something very important. I should write to Cuba at the address of Mr. LABRADA with the carbon paper that he left me, but he warned me not to write to IRMA or to ABUELO I wish you would let me write to IRMA even if it be without lemon so she could see that I have not forgotten her

"As I will be working for a little while in New York, I am mailing you the address of a 'worm' friend who for sure will give me the letter, but you should put on it? For MARIO, pseudonym that MASFERRER gave me and that is how I am known by many of the worms. (b) Better said, many know that is not my name but they have become accustomed to call that The address is as follows: Mr. QUIRING SANABRIA, 581 W. 161st Street, Apartment 53, New York, New York. The telephone is: W. A. 3-5292. (S)

"Take care in how you write since QUIRING is a 'worm. I think you should do it with lemon s

"I await to receive your letters as soon as possible. I'll close here. (\*\*)(\*\*)

Concerning the persons mentioned in the above letter, the following is to be noted: (2)(u)

PACO - identity unknown, but undoubtedly is the same person mentioned in secret messages of during the period June - September, 1963.

[IRMA] - refers to [IRMA] SUAREZ FERNANDEZ (S) reportedly (imprisoned in Cuba for anti-

ENAL refers to EUGENIA ALVAREZ MARTINEZ, who was at one time imprisoned in Cuba for antigovernment activities.

CARMITA, JUAN SANCHEZ, ALBERTO MORALES, and ANTONIO GONZALEZ all have been mentioned previously by CARBONELL in secret messages to Cuba and reportedly have at one time been imprisoned in Cuba for anti-government activities.

Mr. LABRADA refers to ALONSO LABRADA, Neptuno 301, Esquina Aguila, Habana, Cuba, a drop utilized by CARBONELL in sending secret messages to Cuba.

ABUELO - refers to MANOLO GARCIA, Corrales 311, Segundo Piso, Apt. 11, Habana, Cuba, who apparently entertains anti-CASTRO sentiments and who is used by CARBONELL to obtain information relating to anti-CASTRO activities in Cuba.

MASFERRER - probably refers to ROLANDO MASFERRER ROJAS, former Cuban senator and newspaper publisher
