Re Miami airtel to the Bureau and Letterhead Memorandum dated 7/2/70, and Legat, Madrid letter to the Bureau dated 6/25/70, captioned "ROLANDO MASFERRER ROJAS, IS - CUBA".

Referenced letter from Legat, Madrid reflects that on June 19, 1970, the Alto Estado Mayor (Spanish High General Staff - HGS) advised subject had recently arrived in Spain and asked to be furnished with any pertinent information available to the Bureau relative to subject's trip or his background. (X)(u)

Referenced airtel and Letterhead Memorandum reflects that subject is a Bureau fugitive for bond default.

Since submission of the Letterhead Memorandum, the Miami Office continues to receive a substantial quantity of unverified information reflecting subject's alleged presence in Nicaragua, Honduras, as well as Miami and environs.

Miami has not set out leads for investigation in other foreign countries and is not expending extensive investigative efforts to trace out rumors regarding allegations of subject's possible presence in the Miami area in view of the positive information that subject is in Spain. (X)(u)
