DL 202-C-TE was contacted on 9/29/70, 10/4/70, 11/2/70, and 11/18/70. Informant advised SAM BENSON had been operating with EDDIE WALSH of They had an apartment in Arlington, telephone 261-9896 and operated there for several months. September they changed their number and moved to another apartment in Arlington. BENSON and WALSH operated at this location in Arlington until about the middle of October, 1970, when the Arlington PD and DPS men raided the apartment. WALSH was caught in the raid but SAMKBENSON had left 15 or 20 minutes before the raid as he got a call from a customer to go pick up some money. Informant does not know EDDIE WALSH personally but understands he has worked and been associated with R. D. MATTHEWS, a well-known Dallas bookmaker. MATTHEWS is reported to have backed BENSON and WALSH financially.
