<u>ADMINISTRATIVE</u>

The Las Vegas Division's LV 427-C-TE and LV 232-C-TE advised R. D. MATTHEWS is currently operating an unlicensed bookmaking establishment at his residence, 1000 Dumont, Las Vegas, Nevada. MATTHEWS has no other employment other than the bookmaking operation.

On 8/22/74, HO 2449-C advised that JERRY MATTHIAS, a couple of years ago, used to call informant when he needed a prostitute. He advised that he assumes that MATTHIAS, who operates a go-go club, obtains his own girls through this employment, and therefore, did not have to contact source for prostitutes.

Informant advised that frequently the operators of go-go clubs have made the girls who are working there prostitute themselves, and will, thereafter, send them out to other locations.

Informant stated that about one year ago, he believes that MATTHIAS had some kind of a deal in Euless, Texas, and used to turn some girls out of his club to go there and work. He stated that although he has no definite information that MATTHIAS is involved in prostitution, he does feel from some events that have occurred in the past that he is so involved.
