Subject continues to reside at 2207 Greenbrier Street, Irving, Texas, which is the residence of DONNA SUE HELTON, a known prostitute. Records of the Southwestern States Telephone Company, Irving, Texas, revealed no long distance calls were made from subject's telephone during the months of September and October, 1964. Subject's automobile observed parked near the entrance to Redmen Club, 1606 Young Street, Dallas, Texas, frequently.

DETAILS:

On October 7, 1964, LEON POWERS (NA), Assistant Chief of Police, Irving Police Department, advised that one of his officers observed MATTHEWS' automobile at 2207 Greenbrier on the night of October 6, 1964.

On November 24, 1964, POWERS related that spot checks made of the residence of DONNA SUE HELTON, a known prostitute who resides at 2207 Greenbrier, Irving, Texas, indicate that MATTHEWS' 1964 Oldsmobile is usually at the residence during the late evening hours.

On November 9, 1964 and several subsequent dates, MATTHEWS' Oldsmobile has been observed parked near the entrance to the Redmen Club located at 1606 Young Street, during the daytime.

On 8/16/64, DL 185-C-TE advised that he has not heard anything concerning MATTHEWS around the Dallas area for the past two weeks, and that MATTHEWS has not been seen at his usual hang-outs.

On 8/10/64, Mrs. AVA HOWARD of the Southwestern States Telephone Company, Irving, Texas, made available the toll calls charged to BL 4-2584. It is noted that this number is listed to Mrs. BILLY HELTON, 2207 Greenbriar Street, Irving, Texas, and that she is the prostitute wife of BILLY HELTON, who is presently incarcerated at FCI, Seagoville, Texas.

A review of the toll calls reveals that most of the calls were evidently made by Mrs. BILLY HELTON. It is noted that on 6/25/64, a call to H. VALDEZ at Austin, Texas, is a HATTIE VALDEZ, a madam at Austin, Texas.
