AT EULESS, TEXAS. Will contact Chief of Police at Euless to ascertain if he has any recent information concerning MATTHEWS. It is noted that one source acquainted with MATTHEWS advised that MATTHEWS was residing near Buddies Supermarket in Euless.

AT DALLAS, TEXAS. Will contact informants acquainted with MATTHEWS in an effort to locate his present residence and to verify his activities.

## ADMINISTRATIVE

It is noted that the investigative period of this report covers an extensive period of time; however, the Dallas Division had advised the Bureau in referenced Dallas letter which enclosed a letterhead memorandum that the matter was being placed in a closed status. The referenced Bureau letter instructed Dallas to write a closing report in the event the matter was to be placed in a closed status.

Informants acquainted with MATTHEWS in the Dallas area have advised that they have no recent information to indicate that MATTHEWS is active in the Dallas area. From information received, MATTHEWS apparently is spending a considerable amount of time in the Fort Worth, Texas, area.

On 12/23/64, DL 181-C advised that he had recently talked with MATTHEWS and learned that MATTHEWS is residing in the Euless, Texas, area. Informant advised DL 181-C that he was living approximately three blocks back of Buddies Supermarket which is located near Highway 183.

A regular check of the toll calls charged to Irving, Texas, telephone BL 4-2584, since 9/64, indicates that MATTHEWS is no longer using the phone to make his telephone calls. It is noted that prior to 9/64, MATTHEWS was residing with a Mrs. BILLY JCE HILTON, 2207 Greenbriar Street, Irving, Texas, and that the above mentioned telephone was listed to Mrs. HILTON. Mrs. BILLY JOE HILTON, aka. DONNA SUE is a known prostitute and presently traveling in the Texas area to further her activities. It is also noted approximately the first of 9/64, BILLY JOE HILTON was released from FCI, Seagoville, Texas, and is now residing at 2007 Greenbriar, Irving, Texas.
