ADMINISTRATIVE:

On 6/4/65, DL 181-C advised that MATTHEWS was presently residing in Apartment 502--5617 Belmont Street, Dallas, and that he has Dallas telephone number TA 7-4846. Informant advised that MATTHEWS is living at this address with a woman by the name of RUTH WOODS and that this woman claims to be MRS. R. D. MATTHEWS. Informant stated that MATTHEWS has resided in the apartment for approximately one month and that RUTH WOODS has been there for almost two months.

On 6/11/65, DL 135-C advised that on 6/10/65, he was telephonically contacted by MATTHEWS and that MATTHEWS requested the informant meet him at the club known as the Town Pump located on Lovers Lane. Informant stated that the purpose of the meeting was that MATTHEWS claimed the informant owes him \$375 for a poker game in which the informant was involved in, approximately one year ago at the Club Montmarte. Informant stated that he had played poker that night with a Dallas gambler, BOBBY JOE CHAPLIN, and an individual known to him as EVERETT but that he evidently became intoxicated or was given knock-out drops as he found out the next day that he had allegedly lost \$1500 and that MATTHEWS owned 25 per cent of the loss. Informant stated that he does not recall losing this money and that he intends to pay the individuals involved in this game for the loss. He stated that MATTHEWS was very pleasant during the meeting and did not attempt to use any pressure to get the informant to pay the debt.
