Informant indicated that he talked briefly with MATTHEWS at the Redman Club located on Ervay Street on 6/21/65. According to the source, MATTHEWS indicated that he was still residing with his girl friend in an apartment on Belmont Street.

In contacts with other informants who are familiar with gambling and bookmaking activities in the Dallas area, no information has been received to indicate that MATTHEWS is presently active. Informants indicate that MATTHEWS is observed less frequently at the various gambling places in the Dallas area and when observed is usually alone.
