From information received from informant, MATTHEWS apparently is operating, possibly bookmaking, from Apartment 232, 3946 West Northwest Highway, using the name R. C. Miller.

The Dallas Division will continue to cover subject's activities through spot surveillances and contacts with informants and sources in an effort to cover his activities. This information will be reported in the subject's AR file.

On 5/27/66, DL 271-C advised that the subject appears at Denny's Restaurant for a late breakfast or an early lunch on at least two or three occasions each week. Informant stated that on one occasion he observed MATTHEWS with a Dallas sporting goods salesman by the name of DAY KRISTOFFERSEN, whose wife, RUBY KRISTOFFERSEN, is allegedly handling the telephone in a bookmaking operation for JOE CAMPISI.

On 6/10/66, DL 275-C-TE advised that MATTHEWS continues to frequent Denny's Restaurant during the late morning hours. Informant stated that he had not observed any pattern to MATTHEWS' activities which would indicate that he is using the restaurant to meet other characters.

On 6/24/66, DL 275-C-TE advised he observed MATTHEWS' 1965 Oldsmobile parked in front of Apartment 132 and 232 located at 3946 West Northwest Highway, Sherwood East Apartments.

Informant stated that he also has an apartment in this location and observed MATTHEWS' car during the afternoon of 6/23/66, when leaving the apartment house parking lot.
