AT DALLAS, TEXAS. 1. Will follow with Mr. JAMES M. VAUGHAN, JR., Southwestern Bell Telephone Company, concerning the review of toll records when available on telephones available to MATTHEWS and GEBRON.

2. Will continue to spot check and cover the bookmaking operation of subjects at 5315 Columbia Avenue, Apartment 216.

3. Will continue to follow with IRS concerning prosecution of MATTHEWS, on charges pending USDC, Dallas, and will check with the Garland Police Department as to disposition of charges against subjects.

4. Will maintain contact with sources as to subjects' activities.

ADMINISTRATIVE

On 1/16/68, DL 275-C-TE advised that on the evening of 1/15/68, subject MATTHEWS was in his place of business in a drunken condition and at one point started brandishing a pistol which informant told him to put away. TE advised that MATTHEWS is continuing his bookmaking activities and subsequently advised that MATTHEWS in all likelihood was obtaining his betting line from PHILIP S. BOSCO, known Italian bookie in Dallas. Informant also advised that he learned that MATTHEWS' wife has left him or that she has kicked him out. Subject MATTHEWS was married to SHIRLEY FAULKNER MATTHEWS during November, 1967, SHIRLEY being former common-law wife of Dallas gambler EDDIE LEE FAULKNER.

For information of Bureau and Oklahoma City, as soon as the toll records can be made available by the telephone company a detailed review will be made to determine whether a pattern can be established. Previous toll checks will also be considered in this as MATTHEWS was previously involved with GEORGE BARNES of Oklahoma City in connection with his arrest in July, 1966, by IRS.
