## ADMINISTRATIVE

Noted that JAMES L. HARNESS and WILLIAM J. SELMAN are being interviewed at this time. Dallas investigation is currently underway concerning these individuals in case captioned WILLIAM FORD SELLERS, aka. JAMES L. HARNESS, aka, ITAR - GAMBLING, DL 166-62, Bufile 166-263. Informant coverage has been established on the above operation and it has been developed these individuals are handling sports action in the Longview, Texas, area.

On November 12, 1968, DL 271-C advised that MATTHEWS is working with MILTON DEE MALLARD of Austin, Texas, in his bookmaking operation. MALLARD is well-known bookie at Austin and subject of current investigation by San Antonio Office.
