SIMMS is described as follows: NORMA J. SIMMS, nee HIGGINS; white female; DOB 5/6/38, at DeQueen, Arkansas; 5'4"; 135 pounds; brown hair, brown eyes; Social Security #430-66-5883.

There is no information contained in the Las Vegas Office reflecting SIMMS is in any way engaged in any illegal gambling activities.

The files of the Las Vegas Office contain the following information concerning EVERETT C. JOHNSTON:

In investigation entitled, "EVERETT CHOATE JOHNSTON, aka Junk Johnston; ITAR - GAMBLING", OO - Oklahoma City, Las Vegas file 162-1012, Oklahoma City file 166-2044, information therein reflects that JOHNSTON is involved in gambling matters occurring at the Penn Club between Logan and Oklahoma Counties in Oklahoma. In addition, Oklahoma City informants advised subject was residing in El Reno, Oklahoma, as of 6/23/69.

Investigation at Las Vegas at the Credit Bureau of Southern Nevada (PROTECT); the LVPD and the CCSO, determined no information contained therein is identifiable with JOHNSTON.

On 9/3/69, Investigator RAY KOON, Nevada Gaming Control Board, Carson City, Nevada, advised SA ROBERT J. RODEFER, that control board records indicate a letter was received on 3/13/67, from RUSS SCHOOLEY, Investigator of the District Attorney's Office in Reno, Nevada. This letter reflected that JOHNSTON and GEORGE EDWARD BARNES had made inquiries in Reno about obtaining control of gambling at the Mapes Hotel.

Information previously furnished to Oklahoma City by Las Vegas in captioned matter, reflects that telephone number 735-4150 is subscribed to by JOHNSTON, who listed his address as 356 Desert Inn Road, Las Vegas. The date of this application was 6/19/68.

LV 16-C advised SA M. B. PARKER that JOHNSTON has been around the Horseshoe Club, a downtown Las Vegas gambling casino. JOHNSTON allegedly is residing in a trailer court on North Main Street in Las Vegas and efforts are being made by the informant to establish JOHNSTON's exact address.
