On 2/12/70, AUSA B. H. TIMMINS, JR., was contacted regarding the issuance of a subpoena duces tecum to obtain telephone records concerning subject's bookie operations. After the details of this procedure were agreed upon, Mr. ELTON B. MAHON, USA, NDT, requested Mr. TIMMINS make further inquiry with the Department of Justice concerning the procedure to make certain this conformed with the desires of the Department. Therefore, the issuance of such subpoena is held in abeyance pending a determination from the Department of Justice.
