of results of investigation conducted by auxiliary offices subsequent to the submission of referenced report and also due to a delay in dissemination of informant information which is being included in the administrative portion of this report.

On 5/13/70, DL 135-C-TE, contacted by SA WILLIAM B. HOLLOMAN, advised that on 5/12/70, he called JOHN DOUGLAS CAMPISI, DL 166-102, to place bets on two horses running at Thistle Downs. CAMPISI advised CI that he did not handle the bets himself but would lay them off with R. D. MATTHEWS. CI further stated that R. D. MATTHEWS often frequents the Key Notes Lounge, 3806 Cedar Springs, Dallas, Texas, which is a hang-out for a number of Dallas Police characters.

On 6/11/70, EP 583-C advised SA PAUL D. SJDOAL that W. H. PERRY, aka "Egghead" PERRY used apartment 504, 4403 Andrews Highway, Midland, Texas, in his booking operations during the football season, 1969.

He said that names JAMES WILSON and ROY JACKSON are merely "fronts" for "EGGHEAD" and these people do not actually exist.

It is noted that PERRY is a long-time bookie in Midland who reportedly does not plan to book during the 1970 football season. He leases a service station, is coowner of a night club, and spends much of his time collecting stamps.
