ADMINISTRATIVE

DL 135-C-TE on 9/14/70, advised SA FORREST F. JOHN that on that date he had seen R. D. MATTHEWS and two other men he did not know at the Golden Greek, and these men were settling up their gambling debts.

On 9/30/70, DL 135-C-TE advised SA WILLIAM B. HOLLOMAN that on previous date, 9/29/70, he had seen R. D. MATTHEWS at the Chateaubriand Restaurant with owner JIMMY VOURES. VOURES commented to MATTHEWS about how nervous MATTHEWS was and DL 135-C-TE speculated that this nervousness was possibly the result of MATTHEWS' close associate, GEORGE MC GANN, having been murdered. DL 135-C-TE further advised that MATTHEWS appears to be operating his own "book" and probably has someone taking action for him.

On 10/29/70, DL 275-C-TE advised SA WILLIAM B. HOLLOMAN that on 10/28/70, while at the Chateaubriand Restaurant he was introduced to KIRKSEY MC CORD NIX and NIX's younger brother, name not given, by R. D. MATTHEWS, who was with the NIX brothers. MATTHEWS advised that he and the NIX brothers had been arrested on 10/27/70, by the Dallas Police Department, Dallas, Texas, as they were leaving JOE CAMPISI's Egyptian Restaurant. MATTHEWS said he had about \$15,000 in cash on him and KIRKSEY NIX's brother had about \$6,000 cash when they were arrested. MATTHEWS said the money was confiscated by the police and the Internal Revenue Service has taken a lien on the money for taxes that they claim R. D. MATTHEWS owes on his bookmaking operations.

DL 275-C-TE further advised GLENN ERNEST BURNETT had been partners in a bookmaking operation for sometime. He also stated that STANLEY COOK has been closely associated with R. D. MATTHEWS in the past, and although he has not seen COOK recently, ahe does not believe he is working for MATTHEWS in his bookmaking operations.
