Informant advised that (FNU) TROSCLAIR, Deputy, Jefferson Parish Sheriff's Office (JPSO), advised SANG DOMING, a known bookmaker in the Jefferson Parish area, who is an associate of the MARCELLO brothers, that "the heat was on" their bookmaking operation by the JPSO. As a result of this information DOMING had two new telephones installed in his bookmaking operation.
