It is noted that based on investigation in this matter a new case has been opened concerning JAMES B. ESPOSITO, who has been selected as a target under the Top Echelon Criminal Informant Program.

Photograph of subject obtained from his Louisiana Drivers License was forwarded to the Bureau by relet.

Due to information furnished by reliable sources reflecting subject has apparently disassociated himself from former hoodlum friends, this matter is being placed in a closed status and will be reopened in six months for further investigation.
