On July 20, 1967, NO T-2 stated that NOFIO PECORA is the most powerful hoodlum in New Orleans next to CARLOS MARCELLO and JIMMY CAMPO. NO T-2 believes that PECORA is a member of the "black hand."

On July 18, 1967, Mr. MARCEL ABADIE, Supervisory Loan Officer, Small Business Administration, 124 Camp Street, New Orleans, Louisiana, furnished a copy of a loan authorization dated October 14, 1965. This authorization is listed as a disaster business loan to NOFIO and FRANCES PECORARO, 6027 Chef Menteur Highway, New Orleans, Louisiana.

The amount of this loan is listed as \$210,000 at 3 percent per annum. The authorization further reflects that commencing twelve months from the date of the note, NOFIO PECORARO must pay \$910 a month for thirty years. This loan is guaranteed by second mortgage on all land and buildings located at 6027 Chef Menteur Highway and is subject only to a prior mortgage held by the Whitney National Bank.

This file reflects that this loan was solely to repair property damaged in September, 1965 by disaster.
