On 9/30/70, source advised that Mrs. FRANCES PECORA who is a member of the State Insurance Board, voted favorably on a recent rate increase for the insurance industry in the State of Louisiana. Source said that in return for this favorable vote, Mrs. PECORA was able to obtain a loan for \$225,000 from an unnamed insurance company or companies in Baton Rouge, La., to finance the acquisition of the building at 300 Decatur St., New Orleans, La. This building at 300 Decatur St., is a large apartment building in: a very expensive section of New Orleans known as the French Quarter.
