ADMINISTRATIVE:

This case is being retained in P* status inasmuch as subject is not known to be involved in any known illegal activity.

The following information is being included in the administrative pages due to the singular nature of the information as furnished by NO 1283-PC.

On 7/6/71, source advised that NOFIO PECORA has been a close friend of CARLOS MARCELLO for approximately 40 years. Source advised that when ALVIN CRONVICH was running for sheriff that PHILLIP CACCIO, who was connected with CRONVICH's law partner named WAMBSGANS, approached PECORA for a campaign contribution from "the people" for CRONVICH. Source said that PECORA asked CACCIO what CRONVICH would do for CARLOS MARCELLO in return for the contribution. Source said that PECORA said that CACCIO promised that as long as MARCELLO "stays straight" he will be left completely alone. Source said that PECORA told him that he thereafter obtained a total of \$12,000, from MARCELLO, which was delivered to CACCIO for the campaign fund of CRONVICH.
