## ADMINISTRATIVE:

This case is being placed in a closed status inasmuch as subject is not known to be engaged in any known illegal activity. In addition, he is being contacted under the TECIP.

The following information is being set forth in the administrative section due to its singular nature:

NO T-7 stated on 12/28/71, that PECORA is covertly supporting DAVE TREEN in his bid for the governorship of Louisiana, and is overtly supporting EDWIN EDWARDS.

Source advised that PECORA and his wife, FRANCES were in Bogalusa, La., area during Christmas weekend and during this time both talked to a number of friends in an effort to gain support for TREEN. PECORA told the source that FRANCES PECORA had been assured that she will keep her job with the State Insurance Board no matter who becomes governor of the State of Louisiana.

On 12/23/71, NO T-7 advised that he was recently talking to NOFIO PECORA and PECORA told him that a good friend of his, named FRANKIE/BRENT, the entertainer, recently purchased a nightclub at 2201 David Drive, <u>Metairie, La.</u> Source said that PECORA told him that BRENT needed a \$1,000 loan to finance the purchase of some new lounge furniture and attempted to borrow the money from PHILLIP RIZZUTO who had his cigarette machine in the lounge previously. RIZZUTO refused to lend him the \$1,000 and BRENT contacted NOFIO PECORA. PECORA called SAMMY MARCELLO and obtained a \$1,000 loan for BRENT through the Crescent Cigarette Vending Corp., 1240 Montegut St., New Orleans, La. PECORA then told BRENT that if RIZZUTO complained about placing someone else's
