

Rerep SA WILLIAM MAYO DREW, JR., Miami, dated 8/12/65, captioned, "SECOND NATIONAL FRONT OF ESCAMBRAY (SNFE) (OPERATION ALPHA 66); MOVIMIENTO REVOLUCIONARIO DEL PUEBLO (MRP); ALIANZA REVOLUCIONARIA (REVOLUTIONARY ALLIANCE); IS - CUBA; RA - CUBA; NM."

It is noted that the activities of the MRP have been covered in the investigation of the SNFE since it joined with the SNFE. During the past several months there has been no indicating that the MRP is active or participating in the activities of the Revolutionary Alliance other than the fact that MRP leader JOAQUIN GODOY continued to frequent the office of the SNFE.

On September 15, 1965, MM 847-S, an active member of the SNFE, and a close friend of JOAQUIN GODOY, advised that GODOY is no longer active, and during the past months has not been attending meetings at the headquarters of the SNFE - MRP. Informant stated, as a matter of fact, the MRP, as an organization, is practically defunct, since the leading members have abandoned revolutionary activity and are devoting their time to personal pursuits.

In view of the above, Miami file concerning the MRP is being placed in a closed status, and any pertinent information concerning the MRP will be included in communications prepared concerning the SNFE.
