INTERNAL SECURITY-CUBA REGISTRATION ACT-CUBA NEUTRALITY MATTERS

Synopsis:

NY T-1 furnished a letter he received from the Miami headquarters of the Second National Front of Escambray (SNFE) - Alpha 66 - Movimiento Revolucionario del Pueblo (MRP) requesting a contribution together with a letter setting out the "Omega Plan" of the group. Detective JOHN CAULFIELD, Bureau of Special Services, New York City Police Department, advised that the last public affair sponsored by SNFE-Alpha 66 -MRP was held on 1/19/64. SERGIO DIAZ, a member of SNFE -Alpha 66 - MRP, advised that the organization plans no public acts for the immediate future. NY T-1 advised that he received a letter from MIRIAM TESTE of Miami, a member of SNFE - Alpha 66-MRP, who stated that the campaign to raise money was very successful, that various revolutionary groups in Miami are active and that, in the near future, revolutionary elements, including the SNFE - Alpha 66 - MRP, will be fighting inside Cuba MINE ATO ARGUELLES HERNANDEZ, delegate of SNFE - Alpha 66 - MRP, stated that he was optimistic that their organization would do something and that this action would be led by ex-Major ELOY GUTIERREZ MENCYO. ARGUELLES stated that the last public meeting was held in New York on 1/19/64 and that when their fighting forces land in Cubas then they may sponsor public acts to help them financially (NY T-2 advised that he had heard a report that there may be an announcement soon stating that the SNFE - Alpha 66 - MRP would work with the Junia Revolucionaria Cubana (JURE) of MANUEL "MANOLO" RAY.

MEMBER OF SUBJECT ORGANIZATION

DIAZ further stated on March 30, 1964, that the organization still continues to accept voluntary contributions from members and sympathizers of the organization in the NY area. DIAZ advised that what miney is received by the organization is forwarded to ANTONIO WECTANA in Miami, Florida, who is the head of the ALPHA 56 enganization.

MEMBER OF SUBJECT OF SUBJEC

NY T-1, on April 3, 1964, advised that he was in receipt of a letter that date from Miss MIRIAM TESTE who is active in the SNFE-ALPHA 66-MRP in Miami, Florida. In her letter, MIRIAM TESTE stated that the campaign sponsored by the organization to raise funds was most successful.

NY T-1 advised that Miss TESTE in her letter related that various revolutionary groups in the Miami area, at the present time, are most active but are working very quietly in order not to arouse action against them by US authorities.

NY T-1 stated that Miss TESTE wrote that in the very near future revolutionary elements will be fighting inside Cuba and that the SNFE-ALFHA 66-MRP will be part of this fighting.

Miss TESTE also wrote, according to NY T-1, that the Cuban exiles were very much encouraged by what had taken place in Brazil and the successful overthrow of the government of President JOAO GOULART. Miss TESTE wrote that the Cubans were very encouraged by the statement made by Governor CARLOS LACERDA, one of the leaders of the Brazilian revolt, who stated that the uprising in Brazil marked the beginning of the "Cuban Carnival".
