Alpha 66-II Frente-Movimiento Revolucionario del Pueblo (MRP):

NY T-1, on May 13, 1964, advised that he was in telephonic contact with Miriam Teste of the Alpha 66-II Frente-MRP in Miami, Florida. Miss Teste told NY T-1 that there was absolutely no truth to the report that there was an agreement reached between ex-Major Floy Gutierrez Menoyo of their organization and Manuel "Manole Ray of the Junta Revolucionaria Cubana (JURE). Miss Teste stated that the Alpha 66-M Front-MRP was working very quietly and in the immediate future would be fighting inside Cuba. NY T-1 advised that Miss Teste said that her organization would not be inside Cuba by May 20, 1964, as this was too early but would be there shortly thereafter.

NY T-1 also advised on May 13, 1964, that in a letter received from his niece who recently had a letter from Joaquin Godoy of the MRP, Godoy wrote that there was no agreement between their organization and the JURE of Manolo Ray. Godoy also wrote that the Alpha 66-II Front-MRP does not have any working agreement with Manuel Artime Buesa of the MRR.

Junta Revolucionaria Cubana (JURE):

NY T-2, on May 11, 1964, advised that he had been to Miami, Florida, on the week-end of May 2-3, 1964. On the night of May 3, 1964, NY T-2 advised that he met with Manuel Ray, the head of JURE, and made an agreement whereby he would accompany Ray and members of the JURE into Cuba on or about May 20, 1964.

NY T-2 advised that during the week-end of May 2-3, 1964, the last meeting of the National Directorate of the JURE was held. NY T-2 advised that from Ray he learned that the following members of the National Directorate took part in this meeting:

Ray advised that after he departed Puerto Rico and entered Cuba to begin the War of Liberation, Rogelia Cisneros would be the leader of JURE in exile and he, Ray, would head the JURE inside Cuba. Ray also, according to MY T-2 stated that Jose Gomez, Orlando Castro and Jesus Becquer of the National Directorate of JURE would accompany him into Cuba. L

NY T-2, on May 13, 1964, telephonically advised that he had received a telephone call from Manolo Ruy on May 12, 1964, advising him, NY T-2, to proceed immediately to Miami, Florida.
NY T-2, on May 13, 1964, advised that he was then in Miami, Florida. waiting further contact from the JURE prior to their infiltration into Cuba. Z

Infiltration:

NY T-1 on May 13, 1964, advised that in conversation with Dr. Carles Prio Socarras, former President of Cuba, Prio remarked that the raid on the sugar mill of Central Pilon by Manual Artime and the MRR was the beginning of the liberation movement of Cuba from Communism. Prio commented, according to NY T-1, that the group of Manuel Artime is very well equipped and has excellent boats. Prio also told NY T-1 that the infiltration of people into Cuba is the beginning of "the process of liquidation of the Cuban situation." NY T-1 also advised on May 13, 1964 that Carlos Prio had stated that at the present time there are
