to come to some type of an agreement as to the best course of action to take to attempt to get this anti-crime drive of the Attorney General's slowed down. TOURINE also indicated that it appeared the only logical approach open was to attempt to get to KENNEDY through an intermediary indicating the above means would be used.

The informant stated that she had received a post card from FONDA from Miami Beach, Florida, however, FONDA would not state exactly where she was in Florida with TOURINE. FONDA related to the informant that TOURINE appeared to be generally concerned that law enforcement officials would become aware of his activities and stayed in a hotel constantly, only going out from the hotel to "this place" and returning directly to the hotel. FONDA did not elaborate on "this place."

FONDA is believed to have driven to Florida in a 1963 red Pontiac convertible bearing District of Columbia tags and PAT CLARK is known to own a late model Ford convertible bearing either District of Columbia or Maryland tags. It is not known which car DELVECCHIO and CLARK used in Florida or if possibly both cars were taken there.

PAT CLARK and FONDA DELVECCHIO are known to WFO to have actively engaged in prostitution in the past and to be well known to the hoodlum and gambling element in Washington, D. C. DELVECCHIO was alleged to be keeping company with GEORGE ROHANNA, CHARLES TOURINE and JOSEPH NESLINE in the recent past in Washington, D. C. DELVECCHIO is believed to be a respected confident of the above persons and appears to be fully aware of most of the details of their gambling activities.

DELVECCHIO and CLARK have in the past been interviewed by WFO and have been generally belligerent and uncooperative; DELVECCHIO particularly, exhibiting a hate for all "cops."

Both DELVECCHIO and CLARK are described as white females, about 25 years old, 5 feet 3 inches tall, 115 pounds, and very well built.  $\backslash$   $\backslash$
