Telephone #699-6438 was installed in Apartment 104, 136 Kingston Road, Toronto, Ontario, during February 1963 and was disconnected on October 1, 1963. The subscriber to this telephone was Miss June MITCHELL of the above address, who is employed as a stenographer at Reciprocal Managers Limited, Room 102, 183 Bay Street, Toronto. Reciprocal Managers Limited is the holding and managing company of Canadian Reciprocal Insurers of the same address. The latter company is engaged in re-insuring and direct insurance, specializing in fire coverage.

2. On December 20, 1963, the apartment superintendent at 136 Kingston Road, Toronto, Mrs. Wheatley, stated that June MITCHELL resided in Apartment 104 with her sister, Doreen Joan FIELDS from February 1, 1963 to October 1, 1963. When leaving, FIELDS made the statement that she was moving to the U.S.A. Mrs. Wheatley considered both girls to be good tenants; neither girl entertained men at the apartment, however, a number of enquiries were received by Mrs. Wheatley from creditors of Doreen FIELDS after the apartment had been vacated.

On January 3, 1964, enquiries revealed that June MITCHELL is presently residing with her parents, Mr. & Mrs. Henry DESCHAMPS, 31 Sharpe Street, Toronto, Ontario, and that she gave birth to a baby in the East General Hospital within the past three weeks. Mrs. Alex Riddell, 29 Sharpe Street, Toronto, advised that June MITCHELL has been separated from her husband, David MITCHELL, for some time.

> indicated that Doreen FIELDS is in reality Doreen HERRON, nee DESCHAMPS, and that she is presently residing in Florida. Doreen HERRON is separated from her husband, Delmar James HERRON, who is still in Toronto. Delmar James HERRON may be identical to the subject of our FPS #696374, however, this is not confirmed.

6. A check of the Metropolitan Police Department records failed to reveal an entry for June MITCHELL or Doreen FIELDS, however, there is on file a warrant for one D. FIELDS, female, age 20-25 years, 5'3", 105 pounds. This person is wanted for false pretences but it cannot be established that Doreen FIELDS is the same person as D. FIELDS.
