For the information of the Bureau and Miami, telephone number Whitehall 7914 is listed to ROBERT GOLDSTEIN, 10 Bury Street, London, S. W. 1. GOLDSTEIN is an executive of Twentieth Century Fox and his name was mentioned in the Christine Keeler - Profumo affair as an individual who was at least known to Keeler and Mandy Rice-Davies, the two prominent call girls. Additional information regarding GOLDSTEIN may probably be available to the Los Angeles Office or if the Bureau desires, this office can request Scotland Yard to interview GOLDSTEIN regarding subject. The Bureau is requested to advise if they would like GOLDSTEIN interviewed in London.
