Legat, London, relayed request of Scotland Yard for information regarding subject and associates who appeared in London, about 3/6/62. Several offices have furnished information which was summarized in cables to Legat on 3/15, 20, 22, 26/62. Field has set out considerable additional leads not directly related to Scotland Yard request. It is believed this investigation should be handled as part of the A-R matter now that Scotland Yard queries have been answered. This was discussed with General Investigative and Special Investigative Divisions and they concur.
