Re Cincinnati teletype dated 3/17/62; Bureau teletype dated 3/27/62; and Bureau letter dated 4/4/62. U

On 3/19/62 and 4/25/62, CI 407-C, whose identity is known to the Bureau, and who has been attempting to ascertain the exact location of PAUL BELLO, the purpose of his trip abroad and his association with CHARLES TOURINE, furnished the following information: U

Informant stated he has been unable to ascertain any additional information other than that reported in referenced Cincinnati teletype. He stated his inquiry had disclosed that BELLO apparently did not confide his activities to his relatives now living in Steubenville, Ohio. He stated indications are that BELLO is not very close to his relatives. Informant advised that he would remain alert for any information pertinent to captioned matter and should any come to his attention he would immediately report it to the FBI. U

PETE BELLO and CARL BELLO, relatives of PAUL BELLO, are not being interviewed regarding captioned UACB or UACB00. U
