C., metropolitan area, was in Bermuda for several days during the latter part of July. Reportedly, the purpose of Nesline's trip was to locate a gambling establishment. Information previously developed indicates Nesline has been seeking an opportunity to invest a substantial amount of money in a gambling casino to be located outside the United States. Information was also developed from a separate source reporting that Nesline was in Bermuda on July 21 and 22, 1962, accompanied by Charles Tourine, a well-known hoodlum who formerly had substantial interests in Cuba and that they were attempting to establish an interest in a gambling casino. It was further UNRECORDED COPY FILED reported that these two individuals did not travel under their own names; however, it is not known what names or identification they utilized during this trip. It is requested that investigation be instituted in an effort to determine whether Tourine and Nesline were in Bermuda during the pertinent period and whether they succeeded in establishing any interests in Bermuda gambling casinos.
