Re Paris cable 7/16/62.

As indicated in re Paris cable, French police ascertained that NESLINE and his wife arrived in Paris by air June 28, 1962, and no further information regarding them was found. Since Bureau has advised that NESLINE and his wife returned to the United States July 12, 1962, no further inquiry being conducted in this regard. (u)

Also as indicated in re Paris cable TOURINE registered at the Prince De Galles Hotel, Paris, July 6 - 8, 1962. While residing there he was in contact with one JOSEF GAVENTA, born January 3, 1903 at London, England, residing 5 South Audrey Street, London. No further information was available regarding the nature of this contact or the means of TOURINE's departure or destination. (u)

The French Police continue to be alert for additional information regarding TOURINE. The Belgian, Luxembourg and Monaco Police have also been alerted for any available information regarding TOURINE. (u)

The file concerning HINKLE is being closed but the investigation regarding TOURINE is being continued.
