Reference Bucable 7/3/62 entitled "EDWARD LYON HINKLE, JR., aka., IGA - NUMBERS LOTTERY," and Bulet to Paris 7/18/62 in the above caption. *92-2989-128*

On the basis of recable both the Bundeskriminalamt (BKA - West German Federal Criminal Police) and [the Directie Politie (Direction of Police) Ministry of Justice, The Netherlands, *(S)*] were alerted on July 6, 1962 to provide information on the activities of subject and JOSEPH FRANCIS NESLINE. On July 27, 1962, the BKA informed that it had received no information on TOURINE or NESLINE but that a watch notice on them had been published in the July 20, 1962 edition of the "Bundeskriminalblatt."

Both the BKA and [the Directie Politie *(S)*] have been informed of NESLINE's return to the United States and our alerts with them on him have been cancelled. The alerts on TOURINE remain in effect. *(S)*
