Enclosed for the Bureau are 6 copies of a letter-head memorandum incorporating the results of investigation conducted by the Swiss Central Police Bureau, Bern, Switzerland, with respect to MARIO MARCO FORTINI, a resident of Lausanne, Switzerland. (u)

Investigation in Switzerland is continuing in an effort to develop information regarding a reported meeting which is to take place in Switzerland between subject and FORTINI sometime this summer. (u)

In addition, the Swiss Central Police Bureau is conducting additional inquiry to identify ALBERT E. F. GIRARD, a reported contact of the TOURINE gambling group. (u)

Upon receipt of additional information, the Bureau and interested offices will be promptly notified.

Also enclosed is one photograph of FORTINI which was made available by the Swiss Central Police Bureau on 8/17/62. The Bureau is requested to reproduce this photograph and distribute to offices receiving copies of this letter. (u)
