Dear Sir:

With reference to your enquiry regarding the phone calls made by Tourine or Langley at Lausanne, we wish to inform you about the results of the enquiries made by the Police of Canton Basel-Land and Canton Ticino:

The phone number 061 39 48 12 belongs to Dr. Rudolf Abderhalden, domiciled at Binningen, Canton Basel-Land, im Wiesengrund, who is a medical practitioner with own laboratory. Dr. Abderhalden explained that on August 6, 1962, he received the urine of Tourine sent to him by Professor Niehans, of the clinic "La Prairie" at Clarens, Canton Waadt, for examination purposes. From the letter it could be gathered that Tourine lodged at Hotel Palace, in Lausanne, and that his home address was Miami Beach, USA., Causeway Street 79. Dr. Abderhalden does not know Tourine personally and he cannot remember having talked to him at the phone. Nesline Joseph and his wife are not known to him either. Dr. Abderhalden is a world famous medical practitioner and he has never come to the attention of the police.

The phone number 2 13 09 belongs to Miss Ilse Beiling, born 1903, domiciled at Castagnola/Cassarate; number 2 30 09 belongs to Steiger Giovanni, born on November 21, 1901, domiciled at Castagnola; number 2 13 69 belongs to Sauter Ricardo and Ugo, domiciled at Lugano. None of these persons has ever come to police attention and all of them enjoy a good reputation. They have however not been interviewed regarding possible connections to Tourine.
