At that time LANGLEY told informant that he has not been connected with gambline enterprises for more than a year and that he intends to retire from gambling.

According to informant, LANGLEY purchased a house at 6351 N. E. 19th Terrace, Ft. Lauderdale, Florida, where he resides with his wife. LANGLEY reportedly owns a substantial interest in a pizza-pie business.

WFO will follow the activities of NESLINE and subject closely and will advise the Bureau and Miami of significant developments.

Miami will interview GEORGE LANGLEY regarding his association with the subject and NESLINE. In this regard although LANGLEY claims that he has not been involved in gambling enterprises for more than a year, it is likely that he will be contacted by the subject, NESLINE, and other prominent gamblers and hoodlums when they visit Florida. LANGLEY is knowledgeable regarding top-level gambling activity in Washington, D. C., and Florida for a substantial number of years.

WFO feels that LANGLEY would be an excellent target for development under the Top Echelon Criminal Informant Program.

Miami, in contacting LANGLEY, should insure WF 1108-C is fully protected.
