C. area used car dealer, has attended numerous dice games in Washington, D. C., during the past two years and is well acquainted with JOSEPH FRANCIS MESLINE and GABRIEL "GABRY" BOBROV, Washington, D. C., gambleys.

On 8/22/63, WF 1455-C advised SA RICHARD T. HARQUISE that he learned that on 8/17/63, BOBERT JOHN RUGGIENI offered to make arrangements for a \$1,000 loan from TOURINE to ease HAYES LEON COMES, a Washington, D. C. gambler who was formarly engaged as a number backer. According to the informant, COMES did not accept the loan. The terms of the loan were too big, repayment of the \$1,000 at the rate of \$100 a week for 12 weeks.
