

On 9/27/63, PCI ______, advised when contacted, that on 9/18/63, GEORGE RAFT, the movie actor, in the company of CHARLES TOURINE and JOSEPH FRANCIS NESLINE, met with the Counsels of TOURINE and NESLINE, JOSEPH WEINER and PAUL J. BAILEY in the law offices of Weiner and Eailey at Leonardtown, Maryland. PCI informed that this information was obtained from BETTY MORRIETTI (PH), her employer who operates the Hickory House in Lexington Park, Maryland. MORRIETTI (PH), according to PCI, was formerly a subject of a WSTA investigation conducted by WFO where she received a sentence for WSTA activities and also, according to the PCI, is a very close associate of subject NESLINE.

Continuing, PCI stated that during the aforementioned conference, TOURINE and LESLINE requested their attorneys to make contact with the State's Attorney of St. Mary's County
