CHARLES TOURINE also stayed at the Hotel Mediterraneo in Montecatini during the night of July 11-12, 1961, with an unidentified woman, with whom he is suspected of having engaged in immoral relations. Tourine gave no other reason to suspect his activity in Montecatini (While at the above hotels, VAINTRAUB and TOURINE took thermal baths for which the area is famous. They were not subject to any police action [U TOURINE was also at the Hotel Pace from June 24 to July 3, 1960, during which time he took therapeutic/ mud baths. The treatments provoked slight damage to TOURINE, for which he received compensation from the local association During their stay in the above area, neither XEROX VAINTRAUB or TOURINE gave any impression of remaining in the area permanently.
