Information recently developed on Tourine's activities, including his trip to London, England, should be fully developed. Miami, as office of origin, insure that all offices handling investigative leads on Tourine complete their investigation without delay. Recent information indicates Tourine is now in the New York City area. Therefore, the New York Office must institute a detailed and thorough investigation to ascertain his current activities in the New York City area.

Consideration should be given to employing the use of a highly confidential source or technique to accurately determine Tourine's current activities, associates, and business connections. Outstanding investigation should be closely followed by the Miami Office and an investigative report submitted by the New York and Miami Offices to reach the Bureau no later than May 1, 1962.

1 - New York (92-851)

NOTE: Tourine is a well-known hoodlum figure who has numerous contacts with hoodlum factions throughout the country. He has resided in the Miami area since severing connections in Cuba and also spends considerable time in the NYC area. He recently went to London, England, and was the subject of inquiry by Scotland Yard. Last summer, he visited England, France and Italy and reportedly swindled substantial amounts of money from an unknown English businessman. Miami and New York are being instructed to complete all outstanding investigation and submit a report by 5-1-62 and to consider using highly confidential technique to follow Tourine's current activities.
