NESLINE advised the informant that he furnished GEORGE ROHANNA and CHARLIE WHITE (CHARLES TOURINE) with the necessary funds and that they went to the Norfolk area on the weekend of 9/9-10/62, for the purpose of setting up a gambling club in the Hampton, Virginia, area.
